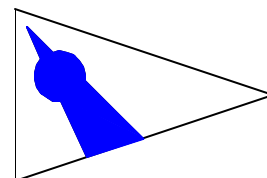




J/22 Mid-Atlantic Championships

Notice of Race



Invitation:

Severn Sailing Association cordially invites you to attend the annual J/22 Mid-Atlantic Championship to be held on the Chesapeake Bay near Annapolis MD, August 17-18, 2002.

Eligibility and Entry:

The regatta is open to all J/22 yachts. Competitors must pay all entry fees and meet all ownership and class membership requirements to become official entrants. Strictly enforced.

Rules:

The regatta will be governed by the Racing Rules of Sailing; the prescriptions of US SAILING; the rules of the International J/22 Class Association; except as any of these are modified by the Sailing Instructions and this Notice. This regatta is designated Category C.

Registration:

Yachts are strongly encouraged to register in advance by completing the attached pre-registration form and sending it with the appropriate fees to:

The entry fee is \$ 85.00 for US Sailing members. Checks should be made payable to "Carl Engel-MAC 2002." Entry fee **includes 3 dinner tickets for Saturday evening, beer and soda after racing Saturday and Sunday.**

Entries received after August 12, 2002 will be assessed an additional late fee of **\$25.00**. Telephone dinner reservations, (Carl Engel at 410.866.3924) will be accepted until August 12, 2002. Telephone reservations must be received by August 12, 2002 to guarantee dinner tickets.

Schedule of Events:

Five (5) races are scheduled from Saturday morning through Sunday afternoon.

Scoring:

The Low Point Scoring System, rule A2 will be used, except that a yacht's score shall be the sum of its points for all races if fewer than 5 races are completed.

Measurement and Inspection:

A valid measurement certificate will be required from the top 5 finishers. Crews will not be weighed, however, all competitors will be required to adhere to the class weight limit of 606.265 pounds. All participants are subject to on board inspection and measurement of hull, rigging and sails at the discretion of the Race Committee.

Prizes:

Fleet 19 will provide trophies. Trophies will be awarded to the top 5 competitors and their crew.

Racing Site:

Racing will take place on the Chesapeake Bay in the vicinity of the mouth of the Severn River.

Launching, Boat Storage, Restrictions:

Launching and hauling for the regatta will be at SSA on Friday through Sunday. Haul-out during the regatta will be permitted. Limited trailer space is available for out of town boats at SSA. All in-town boats must be stored elsewhere. After the last race, haul out priority will be given to all out of town boats. Transient storage before and after the regatta is available upon request at Jabin's Yacht Yard 410.268.9667. Boats cannot be stored at SSA.
